- 1: All lots show Reserves & Estimates.
- 2: Lots will be sold to the HIGHEST BIDDER of any bid[s] received BETWEEN the Reserve & Estimate & to the highest bidder @ 10% ABOVE the SECOND HIGHEST BID received where the bid[s] are ABOVE the estimate. Any dispute to be determined by the auctioneer.
- 3: **ALL** Postal/Absentee bids close @ 12 NOON [CST] Tuesday 5TH MARCH 2019. ALL Bids will be exercised up to the MAXIMUM bid advised on the Bid Form and MUST be in WHOLE DOLLARS. Bids below the reserve will NOT be accepted and WILL automatically be increased to the reserve price in which event the auctioneer will endeavour to contact the bidder to resolve the issue. Where EQUAL absentee/postal bids are received, **priority will be given to the first bid received for that lot.**
- 4: **ALL BIDS RECEIVED BETWEEN RESERVE & ESTIMATE will be exercised at the BID FIGURE.**
